Budget (15 min) - Bonnie

- 1. Bonnie reviewed the FY end budget (Ended March 31), No issues with the FY were brought up at the meeting.
- 2. For the FY 2019, added a Line Item of \$10,000 for "Firewise Prevention". This was added due to the fact that there we no funds anticipated from the DNR, so the board allocated the fund for this worthy cause.
- 3. PLS "Siren" purchase put on hold. Survey will be sent out to membership to see if the siren is necessary and the funds could be used elsewhere.
- 4. Based upon last year's Jolly Mountain fire, the emergency texting and local authorities (Police/Fire/PLS personal) notifying members seemed to be the best solution for the circumstance.

• Road Summary: (5 min) - Ken

- 1. Will be ordering more reclaimed asphalt in March.
- 2. Road maintenance will be starting soon.

Architecture Summary: (5 min) - Bob

- 1. The "Wraparound" Deck will be having some work done on it. The top boards will be removed & replaced with Trek's. The sub-structure will need to be enhanced to "12 inch on center" to accommodate the Trek's installation. Substandard structure will be replaced as needed.
- 2. The area between the deck and hillside will be cleared and paver block added to accommodate 2-3 picnic tables.

Firewise Summary: (5 min) – Loren for Linda

1. There were no funds from DNR for the annual chipping event. The board discussed the matter, and it was decided for PLS to fund the chipping event from the current budget. Motion to fund the event was made by Dave Aldrich and 2nd by Bonnie. All in favor and the motion was passed. There was a "Not-to-Exceed" (NTE) value of \$6K for the PLS funded chipping event tentatively scheduled for end of May 2018.
