- 2. The treasury financial report was re-formatted for clarity.
- 3. There is \$1K left over from the clubhouse special assessment, the monies will be spent on additional clubhouse lighting.

3. Technology: (15 min) - Dave

- 1. Dave is working to collect emails, cell numbers/carriers and names for the text alert notification.
- 2. The siren survey results were tabulated with 71 YES's and 29 No's, we are collecting data on the siren information.

- 1. An additional water hook-up for Double O is anticipated. There are currently 11 in the "Service Area" from Double O, the additional hook-up would bring the total to 12. The anticipated charges are as follows:
 - 1. Hook-up fee = \$ 1,000
 - 2. Setter/Meter = \$ 1,200
 - 3. Labor = \$ 600
 - 4. Then normal monthly water charges.
