## **Old Business:**

#### Secretary - Bob

#### Treasurer - Bonnie

- 1. Bonnie reviewed the April 27th treasurer report, no issues.
- 2. New pool furniture (40 lounges and 40 chairs are planned for purchase, value ~ \$11k.
- 3. Investigate if PLS can increase their credit limit.
- 4. Motion to create "Pay Pal (P/P)" account, this will facilitate Loren to purchase items easier. Mark made motion to create account, Bonnie 2<sup>nd</sup> motion. All voted "YES", motion passed.

# **Member Admin Business / Requests**

- 1. Siren Survey sent to membership, 60% responded to repurpose funds (\$20K) for DNR assessment on how to spend funds for Firewise prevention purposes. Linda to call and talk with DNR for recommendations.
- Mike Bell (2-L-?) informed the board at meeting he wants to put up small "Split Rail" fence on his property, will submit architectural paperwork to PLS.

# **Committee Reports:**

#### Technology Summary: (5 min) - Dave

- 1. Dave mentioned we could install live cameras when we redo the telemetry for the tanks and pumping stations.
- 2. Inland will need to run new lines for added camera with app for Loren to monitor activity on his cell phone.
- 3. Weather station on hold, not enough membership interest.
- 4. Celestina Murphy will be taking over the PLS Website duties from Dave. Transition is in process.

#### Firewise Summary: (5 min) - Linda

- 1. Linda informed the board that there is a new DNR focal point for the chipping program.
- 2. PLS will be paying for a chipping event sometime in the future, email will be sent to membership once planning becomes firm.

## Water Summary: (5 min) - Robb - Loren for Robb

- The new generator will be stationed on a trailer. This will enable it to be used between station 1 & 2 in Division 3.
- 2. RH2 in process of doing assessment on PLS water storage requirements.
- 3. The PLS "Water Plan" needs to be updated, Robb working this effort.

#### Road & Maintenance Summary: (5 min) - Ken & Loren

- 1. PLS ordered ~ 1,000 tons of reclaimed asphalt from ECP in Ellensburg for road maintenance.
- 2. Road equipment scheduled onsite at PLS 6/5 for road maintenance.
- 3. Lignan will be used again for dust abatement again this year.
- 4. Ken will be updating the "5 Year Plan" for road maintenance.
- 5. A Firetruck "Turnaround" will be located at the top of PLS by Thunder Road at the request of Kittitas Fire Dept.
- 6. The road to the PLS clubhouse will be resurfaced with reclaimed asphalt.
- 7. A UTV or snowmobile will be strategically parked with in PLS for emergency purposes.

#### Architecture Summary: (5 min) - Bob

- 1. We have only had 4 tree removal requests from Jan 9thth.
- The trees behind the PLS clubhouse on the Lakebed side are in need to be removed. Need to
  investigate who has responsibility, Fire Service, MaGoogan's (neighbor to North) or PLS. this is
  necessary to protect the new beautifully installed Deck & Railings. Loren and crew did an
  AWESOME job on this much needed update.

### **New Admin Business**

- 1. We are in the process on how to address issue of Renters using the pool, PLS By-law prohibits this issue. Possible solution is issuing Bar Code Cards to members or some sort of Pool Pass option.
- 2. Will be adding some type of VRBO provision in By-laws to state that renters are not allowed to use the pool facilities.
- 3. PLS has rented the "Managers House at the top of clubhouse road.
