Committee Reports: (40 min)

Water: (15 min) - Mark

- Eight bids received for water setter/meter installation. Bid also include hooking water to setters. The board has set aside time to review bid and select installation contractor. Once contractor selected, a few of the board members along with Loren will meeting with contractor to get clarification on a few items.
- Once PLS has chosen contractor to do installation, contractor will generate a "Waterfall Installation Schedule" and layout setter locations, gravel dump locations, etc.
- 3. Setter/Meters ordered, 4-6 week lead time.
- 4. Inland working in Division III to install Fiber-optics.
- 5. Loren to fix a few minor leaks in Division 3.

Roads: (5 min) - Randy

- 1. Waiting for setter/meter installation before we begin road maintenance
- 2. Six year road plan back on schedule
- Road pot holes fixed and gutters cleaned, rented bobcat sweeper. Drainage diches cleaned and free flowing now
- Randy to meet will home owners along Tom Wright Road to discuss road maintenance.
 Hopefully get all parties to form "Road Maintenance Association" for TW Road.
- Letter to go out to member regarding responsibility of "MEMBERS" to maintain their culvert, which includes cleaning to make sure they are free of debris.

- 1. A few bids were discussed regarding replacement of end deck with concrete.
- Also bids to redo coping all around the pool were discussed. ~ \$ 30-40 K, formal bids in 2 weeks.
- Discussion to replace the pool patio furniture discussed in the near future. Quotes to be collected for this effort.
