### 4. Firewise: (5 min) Linda

  Dowing and Rose Schriner. Linda will make contact with the new folks to see where we are
  on PLS Firewise activities going forward.
- 2. Donna provided Linda "thumb drive" with all PLS Firewise data.

#### 5. Roads & Maintenance: (5 min) - Randy

- 1. Roads look "GREAT". Reclaimed asphalt has worked better than expected.
- 2. Lesson for next year is to buy reclaimed asphalt early, this will enable PLS to receive a "Quality" product for next year' activities.
- 3. Sandstone & Lower Highland Loop are inline to receive the reclaimed asphalt for 2017.
- 4. Maintenance activities are going smoothly.
- 5. Pool "Shark" vacuum head is just holding on, it is anticipated that PLS will need a new shark before the next pool season.
- 6. PLS has received another bid for the pool apron and concrete work. Work will start shortly after the pool closes after Labor Day.
- An additional coat of Lignen will be applied to Sandstone this was necessary due to the Fiber
  Optic contractor needing to tear up Sandstone to install their cable. Costs will be paid by the
  contractor.
