- Opening an account at Cashmere Valley Bank. To keep balances below the FDIC insured we need
 to open a new account at a different bank. The total insured by the FDIC is for a single tax
 number, no matter the number of accounts. That is why we can't just create a different account
 at a current bank.

Dave moved to open a new account at Cashmere. Mark Seconded. Unanimous approval.

Treasurers reports

- Reorganizing the reporting into Operating, Reserve, Rental, Total
- Budgets shows that we are over on Roads because of the reclaimed asphalt and the lignin.
- Water looks low but the generator for Div. III has not been spent yet.
- 40 members signed up and paid electronically. 183 set up their profile.
- Aging summary looks good. It looks worse than last year but that is because we split the dues.
- Mark asked to add number of member that are current/not current in their dues to the report.
- Discussed that we need to make sure that promissory notes are renew/signed each year so that we are all clear on the terms and we cover the legal aspects.
- Bonnie and Loren will be speaking with Finanza about services we are getting and not getting and renegotiation of the bill.
